### **Program Overview**

- Limit of one demo appliance unit per partner per twelve months.
- Partner must retain the unit for a minimum of three months.
- Partner must purchase demo unit with one-year maintenance.
- Partner must sell new maintenance when reselling to an end-user.
- Transfer of ownership must occur when partner sells demo unit to an end-user.
- Deal registration or any other additional discounts do not apply to this program neither for original purchase nor for resale.
- All appliance models are available in this program.
- The program is available only to Arcserve partners registered in the Arcserve Partner Program.
- Partner must be both sales and technically accredited

### **Fulfilment Process**

#### **Initial Purchase**

- A distributor places a Purchase Order with Arcserve using a demo unit SKUs listed in the latest price book along with one-year maintenance.
- Demo units are available at a pre-discounted price and no deal registration or any other discounts apply.
- Purchase Order must contain all necessary shipping information.
- All existing policies, including shipping policy, apply.
- The initial owner (distributor or reseller) must keep the unit for at least 3 months.

#### Transfer of Ownership upon Resale

Distributor that was involved in the original transaction must inform Arcserve Order Management team referencing their original PO and place a replacement order which should contain the following information:

- Distributor/reseller details and new owner, end-user details
- Serial number of the demo unit
- Demo unit SKU (as per original PO) listed at zero value, as the unit has been already paid for.
- New maintenance SKU, according to end-user selection Gold and/or Platinum for any duration, including one, three or five years
- Any other required add-ons, including software and/or cards, at a value specified by latest price book, and
  associated new maintenance for any of these add-ons, when applicable
- If any additional hardware is ordered, shipping and other costs may apply according with policies and distributor/reseller needs. Shipping address and/or any other shipping instructions should be clearly indicated in the order.
- Replacement and installation of any add-ons is a sole responsibility of the partner/end-user.
- New owner will receive a new license certificate with associated maintenance and support entitlements issued in the new owner's name.

**Note**: Maintenance purchased by initial owner (partner) will not be reimbursed if the unit is resold before maintenance expires.
